

General Terms of Use

This page states the Terms of Use ("Terms") under which you ("You") may use the BetterHireS Site and the Services (each as defined below). These Terms include the BetterHireS Privacy Policy, which is incorporated into these Terms by reference.

These Terms constitute a binding agreement between You and BetterHireS, LLC. or the BetterHireS company operating the Web site for the country in which You live or in which business is headquartered ("BetterHireS") and are deemed accepted by You each time that You use or access any BetterHireS Site or BetterHireS Services. If You do not accept the Terms stated here, do not use the BetterHireS Site and the BetterHireS Services.
